Post Presents the Nintendo Switch Instant Win Game ("Promotion") is sponsored by Post Consumer Brands, LLC ("Sponsor"), 20802 Kensington Blvd, Lakeville, MN 55044, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Promotion begins on September 1, 2017 at 12:00 PM (noon) Eastern Time ("ET") and ends on March 31, 2018 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion's official clock.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Nintendo of America Inc., and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (collectively, the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's ("Entrant") full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Promotion, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. If it is discovered or suspected that an Entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, all of that Entrant's entries will be declared null and void and any prize an Entrant might have been entitled to win will not be awarded any may be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any Entrant attempting such use.

  - A. Purchase participating product:** During the Promotion Period, Entrants may purchase a participating product to obtain either a unique Code printed on the inside of the box of the boxed participating products or a common Code printed on the bag of the MOM bagged

participating products, while supplies last. For a list of participating products see Section 13 below.

Special Offer: Entrants who purchase a boxed participating product to obtain a Code will receive Fifty (50) My Nintendo™ Platinum Points (“Special Offer”), while supplies last. The Points Code can be redeemed at [www.mynintendo.com](http://www.mynintendo.com). A free Nintendo Account is required to receive and redeem My Nintendo Platinum Points using the Points Code. By creating a Nintendo Account, user will be automatically enrolled in the My Nintendo rewards program. My Nintendo Rewards Points Terms of Service apply [https://accounts.nintendo.com/term\\_point](https://accounts.nintendo.com/term_point). Points Codes must be redeemed no later than December 31, 2018. Once added to your Nintendo Account, My Nintendo Platinum Points expire within six months. Any unredeemed Points Codes are null and void. There will be no more than four million two hundred thousand (4,200,000) Special Offers available during the Promotion Period. The Special Offer is only available to Entrants using a Code obtained via the purchase method set forth above.

- B. Without a Purchase Mail-In (August 20, 2017 through March 15, 2018) Code Request:** To obtain a Code without making a purchase, an eligible Entrant must legibly hand write his/her full first and last name, complete street address (no P.O. Box), age, and valid e-mail address on a 3½” x 5” properly stamped postcard and mail it to: The Post Presents the Nintendo Switch Instant Win Game Code Request, P.O. Box 251328, West Bloomfield, MI 48325. Requests sent in an envelope will not be accepted. Mail-in requests must be postmarked between August 20, 2017 and March 15, 2018 and received by March 22, 2018. Administrator will send one (1) Code by e-mail to the e-mail address provided on each postcard received. Each Entrant may mail in no more than three (3) times per day and obtain no more than three (3) Codes per day (as determined by the name and email address on each postcard), total, through this method of Code request. Mail-in requests will not be returned and no further correspondence will be entered into. Mail-in requests must be original and legibly hand-written. No mechanical reproductions are allowed.
- C. Without a Purchase Online Code Request (March 16, 2018 through March 31, 2018):** From 12:00 AM ET on March 16, 2018, through 11:59:59 PM ET March 31, 2018, an eligible Entrant must visit <http://NintendoSwitch.Postsweepstakes.com/AMOE> and follow the onscreen instructions to obtain one (1) Code without a purchase. Entrants can request up to three (3) Codes per day via this method.

Each Code from a boxed participating product is unique and may only be used once during the Promotion Period. Each Code from a MOM bagged participating product is common and may be used one (1) time per day. **Regardless of how many Codes are obtained by an Entrant or the method used to acquire the Codes, there is a limit of three (3) Code entries per Entrant per day during the Promotion Period.**

- 4. HOW TO PLAY THE INSTANT WIN GAME:** During the Promotion Period, an eligible Entrant must visit <http://PostSweepstakes.com/NintendoSwitch> (“Website”), and follow the on-screen instructions to enter, which include providing his/her date of birth. If it is the Entrant’s first visit to the Website, then he/she must complete and submit the registration form by affirmatively agreeing to these Official Rules and providing the information requested by Sponsor which may include, but not be limited to: complete first and last name (initials are not permitted), street address (P.O. Boxes are not permitted), city, state, ZIP Code, daytime phone number, valid e-mail address. Regardless of if an Entrant has already visited the site to register, after registering and submitting a Code, the Entrant will receive one (1) instant win game play

("Game Play"). After the Game Play, the Entrant will receive notification on the Website screen as to whether or not he/she is a potential winner ("Game Notification"). Each Entrant who receives a winning Game Notification will be deemed a potential prize winner, pending verification of the Entrant's eligibility and compliance with these Official Rules, as determined by Sponsor or its representative in its sole discretion. An Entrant is not a winner of any prize, even if the Website/Game Notification should so indicate unless and until Entrant's eligibility and the potential winning Game Play have been verified as determined by Sponsor or its representative in its sole discretion. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. ## **5. PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE ("ARV"):**

**A. Prizes (500):** Each winner will receive a Nintendo prize pack that includes a Nintendo Switch™ system plus a Super Mario Odyssey game (each a "Prize"). There will be no more than five hundred (500) Prizes available in the Promotion. The Approximate Retail Value ("ARV") of each Prize is \$359.98.

**B. Total ARV:** The total ARV of all available prizes in the Promotion is \$179,990.

**C. Odds of Winning/Limit:** The odds of winning depend on when the Entrant completes a Game Play. Prizes will be made available at random times throughout the Promotion Period. To be a potential winner, an Entrant's Game Play for a specific Prize must have occurred either at the exact randomly predetermined winning time for that specific Prize, as determined by Administrator. If a Game Play does not occur at the exact randomly predetermined winning time for that specific Prize, then the next Entrant's Game Play for that Prize to occur after that time will be deemed a winner.
